Teens work together with professional teaching artists to learn basic art skills, research, design, and install murals throughout King County and beyond.

Base Crew: The Base Crew provides year-round mentorship and training for teens who have completed the Mural Apprentice Program who wish to deepen their arts and design experience. This program is a pathway for youth to become future muralists, teaching artists, and arts leaders.

Commissioned and Community Murals: We work with community organizations and business owners to facilitate interactive community engagement around the research, design, and installation of murals and public art in specific communities.
